2 Annual Reports

Note: In advance of Althing, anyone holding a Committee or Non-Committee role was contacted and asked to prepare a report which answered 7 questions. Some questions are not applicable to all roles.

2.1 Reports from Committee Members

2.1.1 Activism Representative (Paul Nolan-Paley)

What were the highlights of your work for Committee this year?

- The activism workshop at Winter Wonderland, though attendance was low compared to the size of the event.

Is there anything which you would like to have done which you didn't manage to do in the year?

- Activism

How are you feeling about the role?

- This is a role which has lacked a framework since it existed as Campaigns rep before the pandemic. Naturally, the core committee team have been focused on events and bolstering numbers, but now would be an ideal time to utilise those numbers for youth empowerment and generate discussion on how DFs can do activism

Anything you've found difficult which you would like to review?

- Two main barriers to feeling empowered to take action in this role:
 - Lack of clarity on how political DFs are "allowed" to be within the context of the wider charity.
 - Lack of interest from members and external organisations (or perhaps people don't realise DFs have an activism rep)
- We also haven't been receiving invites to the co-op meetings, which used to be frequently attended by the activism rep, so this should be looked into.

Anything else you would like to add?

- Activism is crucial in enabling youth empowerment, which is a core goal of Woodcraft DF's. Whilst there are valid discussions to be had about redefining the role, and whether it needs to be committee or non-committee, abandoning it at a time when DF's is gaining so much traction and when the right to protest is under increasing threat would be a serious misjudgement

2.1.2 Chair of DF Committee (Tyler Eckersall)

What were the highlights of your work for Committee this year?

- Being so so proud of everyone after seeing our work come together time and time again. Autumn Nocturne was the strongest start we could have asked for, and our events have just got bigger since. I think DF Committee is stronger than it was this time a year ago, and that makes me very hopeful for the future.

Is there anything which you would like to have done which you didn't manage to do in the year?

- The DF committee internal comms system needs a rework. I'd like to work on a discord server instead of a group chat for next year's committee, but I'm unsure if I will have time before old/new.

How did your handover go?

- My handover was about one sentence long. After serving a year in this role - this makes a lot more sense to me now. Being Chair of Committee is completely different person to person, and so trying to hand it over is a difficult task. This year, I have some guidance on internal comms to give to my successor, but not much else!

2.1.4 Events Representative (Nuala Doak)

What were the highlights of your work for Committee this year?

- DF Camp felt like the most immense culmination of intense hard work and will always be the camp, which I will remain proud of for the rest of my life. I would like to take a moment to thank the incredible team of people who have dedicated so much of their time and energy to creating such a wondrous event, enjoyed by everyone in its attendance. Cheesy Night and The Freak Map will go down in DF history, worming their way into archives, just as Delilah, the previous DF Chair, who led the DF History Workshop taught us. This camp birthed an even deeper appreciation for DF's than I

This is a conversation I want to raise and speak about now (at Allthing) because I think we continue to mildly miss the mark about Spring Awakening, despite the incredible events we've had.

2.1.5 Fundraising Representatives (Parker Murray and Noah Williams)

What were the highlights of your work for Committee this year?

3 Treasury Reports

This continuity has been vital for cleaning up the books and bringing our finance practice up to a standard that will allow application for grants and other great stuff.

4 Motions

Tyler explained the hand signals used in democratic discussions in DFs, including quotations from the A to Z of Good Discussion.

4.1 Motion 24-01 (No Brunch)

Proposed By Nyx Cook-Hayward

BODY This DF Althing believes there should be no brunch on DF

events. Ever.

RATIONALE If you were at summer camp, this will be self-explanatory.

Tyler presented the motion on behalf of the proposer. At DF Camp 2024, there were two mornings with Brunch instead of Breakfast and Lunch. It was agreed that the end effect of this was less food for participants, which came as late as a normal lunch, and which delayed the start to the day. Althing acknowledged that the theoretical basis of brunch on DF events (reducing work for early-morning

cooking clans) was sound, but that the execution was not good. There was a low temperature on overnight oats, but a proposal was accepted for a recommendation for simpler breakfasts.

4.2 Motion 24-02 (Change to the Food Policy)

Proposed By Paul Nolan Paley

BODY This DF Althing changes section 4 of the <u>Food Policy</u> of the

Movement to reflect what is, for the most part, already practised on camps. The proposed edits to section 4 can be

found below.

RATIONALE These changes would set a standard that DFs should not

expense meat in line with our values of running as ethically

and sustainably as possible

The production of meat and other animal products can have a burden on the environment and is important in planning a meal as sustainability is a key aspect of our movement. Preparing meat also presents more food hygiene risks than vegetarian/vegan options. It is suggested to make Vegan meals whenever practicable as they can be more sustainable and allow everyone to eat it rather than creating many different meals.

While this is true, a fully vegan event is not inclusive to everyone, coming to a DF event can be a difficult step and we should strive to make people feel welcome and comfortable. Therefore, As a middle ground that reflects an effort as a movement to be more ethically and environmentally conscionable, camp menus should be made fully vegetarian, and vegetarian protein sources should be provided in an appropriate amount across the event. This is not designed as a ban on meat from camps, but as a guideline that KPs should not include meat in camp menus, and that meat products will not be expensed for events. A reasonable exception to this is when allergens mean an individual(s) on camp are unable to meet their protein requirements from vegetarian sources, or when other medical requirements render meat essential to their diet. meat and other animal products should be provided in an appropriate amount across the event. e.g. bacon/halloumi for breakfast, meat/cheese in sandwiches, cheese to add to pasta, etc. Vegetarian protein sources should be provided in an appropriate amount across the event.

Concerns about cruelty to animals are important as people may not be comfortable with an event supporting these industries and should be considered when finding suppliers. In order to reduce discomfort, the Clan Rota should make

sure that people preparing meat are meat eaters and that clans have a fair balance of dietary requirements.

Tyler presented the motion on behalf of the proposer and summarised the proposals. Nuala explained that the DF Camp coord team had a discussion on this topic which generated this motion. Concerns were raised about complaints from participants and about placing too many limits on KPs who already have many competing factors to consider when catering a camp

Tyler summarised the sense of the meeting as support for the content of the motion but a reluctance to enshrine all of its requirements in policy, given that coord teams always have their own negotiations on this issue for each event. The food policy is in need of review, and Winter Thing will be a better forum to workshop finer wording changes.

Action: Update the Food Policy at Winter Thing 2024

4.3 Motion 24-03 (Preventing Laymember Overexertion)

Proposed By Tyler Eckersall

BODY This Althing sees an addition to section B.1.5.6 of the

constitution, specifying that the laymembers may not also

hold another Committee Role

RATIONALE Last year, DF Committee had to co-opt a new laymember

after the elected DF (who also held another committee role) realised they had unknowingly taken away a space of a DF not on Committee. Similarly, in the past, we have had issues with laymembers being unable to complete their role of easing other DF's workloads because they themselves are

hard at work on a separate woodcraft project.

No longer permitting the laymembers to have another committee role should mean that we maximise involvement in DF committee, whilst also helping to keep everyone's

workload slightly more balanced.

Tyler presented the motion and clarified that this did not prevent holders of non-committee roles from holding the Laymember role. It was raised that this motion aimed to prevent committee members from taking on too much responsibility, but the Constitution still allows roles such as Events and Chair to be held by the same person.

A proposal was made to pause the discussion and resume after Motion 24-08 Althing reconvened to discuss the motion. The focus of the proposed amendment was to avoid overexertion of all committee members but concerns were raised about emergency situations developing where there weren't enough nominations to cover all Committee roles.

Amendment: This Althing changes section B.1.4.6 of the constitution so that one person may not hold more than one role on DF Committee.

The amendment passes.

The meeting moved to take a vote on the amended motion: This Althing changes section B.1.4.6 of the constitution so that one person may not hold more than one role on DF Committee.

4.4 Motion 24-04 (Altering the two-stage Election Process)

Proposed By Tyler Eckersall

BODY This Althing will see section B.1.7.1 and B.1.9.1 of the

constitution altered to allow elections for Chair of DF

Committee and MEST-UP Coordinator to no longer require a second round of voting if there is one candidate who has been selected as EVERY voters first choice on the ballot form.

RATIONALE Currently, the elections for Chair of DF Committee and MEST

UP Coordinator require a second round of voting to happen after the entire movement has had their say, in which the newly elected DF Committee and the MEST UP reps choose their respective coordinators. This makes a lot of sense in an

election that is highly contested, but for specific

circumstances where there is only one candidate running

alongside RON for each role, I believe this causes an

unnecessary admin headache for the person running the election.

I think that if one candidate is everyone's first choice, ensuring that not even one DF placed RON first, then this second election should be no longer required. We need to ride the Althing momentum as a movement and we don't need this extra step getting in the way.

This process should absolutely remain for all truly contested elections.

Tyler introduced the motion and explained the current system. It was suggested that it might make sense to extend the motion so that any election with just one candidate does not require a second round, but this would remove the possibility of the second round voters collectively rejecting a lone candidate and leaving the position vacant or re-opening nominations.

4.5 Motion 24-05 (Change to the Shift Policy)

Proposed By Esme Thompson

BODY This DF Althing updates the Shift Policy to make the

following provisions for large DF events:

• At least two people on shift trained in MEST-UP

- At least two people on shift trained in first aid
- A 1:10 ratio of sober adults to other participants

RATIONALE This reflects current practice in DFs and external guidelines.

Wilf presented the Motion on the proposer's behalf and explained the provisions in the current shift policy:

- For events under 50 participants, a minimum of 2 people on shift
- For events over 50 participants, a minimum of 4 people on shift
- Every shift must contain one MEST-UP and one First Aider

There were concerns that the new policy requirements would be too high to meet at every event, but also a recognition that written documents produced by DFs are always aspirational in nature and should present the best picture of what

should be done. The idea of a 'get out' clause was floated, but it was pointed out it was unwise to create contradictions in policy instructions.

Discussion moved to shifts on DF Camp 2024. This event was the first to expand the Coord/Committee shift to a general volunteering shift for those who wish to take on responsibility on camp. Althing agreed that there were aspects of the implementation of this new 'Orange Shift' that could be improved. The volunteers on Orange Shift were often not well-informed enough to perform the role previously filled by Coord/Committee Shift, meaning that off-shift coordinators were often called upon by participants. Althing recommended that Orange Shift volunteers be made aware of the following things in a meeting at the start of an event.

- The location of important resources on camp
- Their responsibility for recording participants leaving and returning to site.
- The kind of support for the operation of the event that they are responsible for.

Althing additionally recommended that:

- Handover between shifts be improved, with a defined time, location and content of handover between Orange Shift volunteers.
- A role description for the Orange Shift be prepared at Old/New.
- That more members of DF Committee receive safeguarding training so that they can act as the event Safeguarding Lead, who currently has oversight over shifts.

Action: Investigate Safeguarding training for more members of Committee

It was noted that the practicalities of shifts during the day and during the night are very different, and that the recommendations are good for the higher demands of night shifts, but that numbers do not need to be as high for day shifts.

Amendment: Create a distinction between day and night shifts in policy and retain the existing rules for day shifts and only apply the new numbers to night shifts on large events.

Amendment passes.

The first two points of the motion cover the DF-conceived notions of peer responsibility and 'shifts', whilst the third covers broader legal guidelines for residential events for children, taken out of the DF context. It was suggested that the third point is therefore an assumed baseline which is beyond the scope of collaboratively edited DF policy.

This DF Althing updates the <u>Shift Policy</u> to define a difference between nighttime and daytime shifts and to make the following provisions for night shifts at large DF events:

- At least two people on shift trained in first aid

The policy for other shifts will remain those currently written in policy.

4.6 Motion 24-06 (Manchester Liaison)

Proposed By Thomas Boxall

BODY This Althing removes the non-committee role of Manchester

Liaison from the DF Constitution.

RATIONALE It is recognised that the Manchester Liaison Role was a role

created by DF democracy, but it is pointless and was created

at a camp with a large Manchester group.

Althing acknowledged that the regional liaison roles - that is non-committee DFs taking responsibility for increasing DF engagement on a local level in their own region. However, a truly decentralised regional model needs all regions to be represented, and there is not currently capacity for a full suite of regional reps. Althing praised the effectiveness of London and Scotland (practically, the Central Belt conurbation) as local centres of DF action, but it was suggested that other potential regions are either too disparate (eg. Wales) or do not have large enough DF populations (eg. Manchester).

At the same time, Althing recognised that it was important to retain constitutional provision for roles like these so that they can be filled if a willing DF and regional DF community appears.

BODY This Althing sees an addition of another Events

Representative to the role of 'Events', making it a two person

RATIONALE The Events Representative undertakes an extensive

workload, which can be a great source of stress and

incredibly overwhelming. This motion seeks to protect the Events Representative, ensuring that they are never left alone

in their role.

The implementation of this would mean that both Events Representatives would have a vote on Committee, as well as

being expensed for Things.

Nuala opened discussion on the motion. The cause of stress for the Events Rep in the past year was agreed to be a failure of support systems on Committee and not the nature of the role *per se*, but action is needed to protect the holder of this demanding role from burnout. The Events Rep has a large responsibility for coordination of different teams. This means it is easy for the role-holder to take on too much responsibility without meaning to. Althing agreed that looking into underlying issues with events coordination could be more productive than increasing the number of reps permanently - the '22/'23 Committee had two events reps and was not necessarily more successful with this issue. Althing noted that the Events Rep or Reps should never be required to come to every social event or be heavily involved in its coordination.

Action: Old/New to compose a new set of Coord Team role descriptions

continuing our organisation through institutional

frameworks (committee) and the coordinators of grassroots

action to actually achieve the Movement's aims

(non-committee).

Althing agreed that the sustainability of the Movement was integral to its functioning and that therefore it was inappropriate to have the Sustainability role off committee. Like accessibility, the holder of this role should be able to act independently of Committee, as a critic where necessary. No other roles were approved for movement. The agreed change was formulated as an amendment and voted on.

Amendment: Include reference to supervisory roles and specify the change as making sustainability a supervisory role

To:

B.1.2.4 Delegation of Powers

In order to achieve the above purposes, the DF business events (see section B.4) or DF Committee may from time to time establish Moots with delegated powers.

B.1.2.4.1 The purpose and powers of a Moot should be clearly defined and it may be established for a limited period or on a permanent basis.

B.1.2.4.2 A Moot must update the Movement on its work at Business Events, through verbal or written reports, proposals or motions.

B.1.2.4.3 A Moot **must** appoint a chair, who is responsible for coordinating the group and chairing meetings.

B.1.2.4.4 A Moot **may** appoint a secretary who is responsible for record-keeping for the group and minute-taking at meetings and may appoint any other roles designated by the Moot.

B.1.2.4.5 A Moot may have a closed membership defined by DF Committee or the Business Event that establishes it, or may be open to

RATIONALE

Jack Brown's DF Standing Orders contain references to 'posses' /'pɒ.si/ (definition)., which seem to have been permanent sub-committees open to all members of the Movement and chaired by a member of committee, for example the 'Finances and Fundraising Posse', chaired by the Treasurer.

This is funny because me and Tyler were just talking about establishing proper constitutional support for working groups and brainstorming a special DF name for them at DF Camp this year.

The concept itself is not unfamiliar to DFs in 2024. Currently

The moot will be in operation until Althing 2026, at which point its work will be transferred to the 2026/27 Committee.

The moot will be chaired by the Shadow Events

Representative of DF Committee and will also appoint a secretary. The moot may from time to time create other roles (eg. comms, kinsfolk liaison, budget adviser etc.) to be taken

on by its members, according to the plans it makes. Membership of the moot is open to all DFs and will be

promoted in national comms.

RATIONALE Delilah's history of DFs workshop at DF Camp got people

talking about the upcoming anniversary. It feels like a long way a way so it would be easy for it to fall by the wayside if we don't create a space in our organisation dedicated to it.

Campl00 and Vcamp 2026 are the two key milestones between now and our anniversary and we don't want to let them pass us by without using them to build up this project so let's get started now!

A motion or even a musing is too short to contain all the ideas that could go into Project 2027, so we need to create a group that will meet regularly outside Things and social events to work on them. Additionally, a good proportion of the 24/25 Committee won't be part of the Movement by 2027, so it's not really up to us to lead the discussion.

4.12 Motion 24-12 (No clan for coord team)

Proposed By Nyx Cook-Hayward

BODY This Althing recommends that members of the coord team

for a DF event are not included in the event clan rota.

RATIONALE

Coord teams do so much to make these events run smoothly both before and during the event. Therefore this would ensure that the work of making the event enjoyable and good would be spread more evenly among all attending dfs. This would also incentivise more people to step forward to be a part of coord teams, meaning that more events could be run, they would be much more stress-free for those organising, and again the burden would spread more evenly among dfs. This does not mean that the coord team would be doing nothing on the event, of course that would not be the case. Instead, they would be available all day whenever they are needed to help with anything that their specific role requires rather than being bound up by being on clan. For example, the kps would be available to help with cooking clan, restocking the snack table or to help someone who accidentally missed a meal, the programme team would be able to dedicate their day to running and preparing for the programme activities that have been planned for that day/ the event, the kes would be available to help with site tidy clans/ any technical difficulties that occur while on the event, the admin coord team would be available to check that those going off site are not on clan/ have found cover for their clan to help combat the lack of dfs that actually turn up for clan. Additionally, all teams would be available to help with any general concerns or qualms to do with the running of the event all day- such as clan wrangling, which would also help to combat the lack of dfs turning up for clan.

Wilf presented the motion on the behalf of the proposer. Everyone at a DF event should contribute to the management of the community, which is why clan is so important to the way we operate, and why skipping clan is not acceptable. Althing agreed that event coord teams make a very large contribution already. This contribution starts well before camp and coord team members are regularly called upon during the event. For this reason, Althing agreed that inclusion of coord team members on the clan rota, giving them additional work was not desirable.

The meeting moved to take a vote on the motion.

held in 2024-25 by someone from Bristol who has never visited Manchester. But it was created by DF democracy and should serve as a reminder of poorly thought out decisions,

the tyranny of the majority etc.

5 Musings

5.1 DFs in the Summer of 2025

Seren led a discussion on DF plans for the Summer 2025. DF camp has had to be scaled back in recent years when Woodcraft has held a Big Camp nationally - Common Ground in 2022 and Vcamp in 2023. There are concerns that there will be fewer people to volunteer and attend a week-long DF Camp and Althing weekend soon after Camp100 next summer. Althing split into two breakout rooms to discuss the issue and reconvened to compare conclusions. Althing recommended that DFs should hold a combined Althing and DF camp about a week after Camp100 over four nights.

It would offer an opportunity to integrate more DFs in 2025's elections and democratic processes and could be prepared with democracy workshops throughout the year. The combined event may be billed under the DF Camp name, the Althing name or a third alternative name.

Althing wants to continue to promote volunteering by DFs at Campl00. Workshops and discussions will continue at DF events coming up in the next year. Althing wants to make it easy for young volunteers to find a role that suits them. Anna plans to develop a flowchart-style guide or online tool that will help with this. Its distribution will be supported by DF Comms.

Althing particularly encourages young people to stay for Camp100 takedown and arrive early to help with Working Week. A large DF presence in these efforts would be positive for the Movement's image and make a good social environment.

5.2 Internal Comms

A Musing developed over lunch about internal communications on the New Committee that was to be elected. Internal comms will be improved for the new committee to allow everyone on Committee to know what's going on with different roles and to improve division and coordination of labour. Suggestions were made for a change in the platform we use for DF Business. WhatsApp Communities as an alternative to disparate chats were suggested, as well as a move to a Discord server, as has been done for Vcamp and Camp100 coordination.

5.3 Spring Awakening

Nuala led a discussion on the nature of the Spring Awakening event. Spring Awakening 2024 was cancelled by the site managers due to an electrical fault developing leading up to the event. The Spring Awakening event is usually smaller because it falls before the beginning of exam season for those in education. Althing recognised that it is more useful to work on cultivating a good atmosphere on a scaled-back event than to aim for a large and ambitious event that will not attract as many bookings or be supported by a large team of volunteers. The ambition in the planning and the execution of a Spring Awakening event is a function of the exam stress of those involved.

Althing recommended that Spring Awakening would work well in 2025 as a chiller, smaller event with a focus on wellbeing, led by MEST-UP. Quiet time to make revision possible should be built into the programme. It is hoped that for those who do choose to attend, the event will have a positive impact on their wellbeing as they enter a stressful period of their education.

5.4 Integration of different groups of DFs

Wilf introduced the musing on the behalf of Nyx. The musing aimed to find ways to integrate different social groups of DFs on larger camps, where cliques are often present. The decisions coordinators can make through programme and other camp structures were up for discussion.

Camp Friend was mentioned in the introduction to the musing and Althing agreed with the muser that its focus should be on creating social connections rather than anonymous gift exchange. Joe Hammond expressed Althing's view concisely with the following:

'Do something with your Camp Friend, not just for them.' However, this guidance can only ever be guidance as the breaking down of cliques through programme and other coord team action is only effective if accompanied by a cultural shift across the whole event.

Smaller events are less prone to division and elements of camp design (eg. the location and attractiveness of the smoking area) have a noticeable effect on where people congregate and the cliques that form. Working together to run camp is the best way of creating a unified social group, so clan work, clan

teambuilding and grassroots organising for games and activities (walks, ratchet screwdriver, ball games, card games) rather than top-down programme are very effective. Althing remembered positively the increase in contributions at Circle by ordinary participants over the course of DF Camp. It was also reminded of the fact that the coord team and DF Committee are in fact the 'biggest and best clique of them all'. They should lead the cultural shift they want to see.

6 Hustings

Nominations for 2024-2025 Committee and Non-committee roles were closed. The list of roles remaining to be filled can be co-opted after Old/New.

The list of roles was read out and one-by-one each person gave their short hustings speech. Candidates running *in abstentia* had submitted hustings speeches in advance. These we read out and committed to the minutes

6.1 Committee Roles

6.1.1 MEST-UP Coordinator

Joseph Hammond (20)

I have been shadow MEST-UP coordinator for a year and am now ready to take over as MEST-UP coordinator

6.1.2 Shadow MEST-UP Coordinator

Martin Munns-Faleyev (16)

I am very interested in learning about supporting, organising MEST-UP, and being involved with such things in the future

Alyx Langford (17)

As someone who's been helped a lot by the people in MEST-UP I understand how important the space is and want to give something back and help others in the same way. I am a good listener and feel like I could do lots in the role because I care about people and want to help in any way I can.

6.1.3 Events Representative

Wren Chambers (17)

I enjoy helping others and being able to participate and see my impact in events and in the woodcraft community. I want to be elected for the role because I am good at organizing and able to listen and take on advice and build on it in group discussions. I want to be able to see my impact in woodcraft.
